



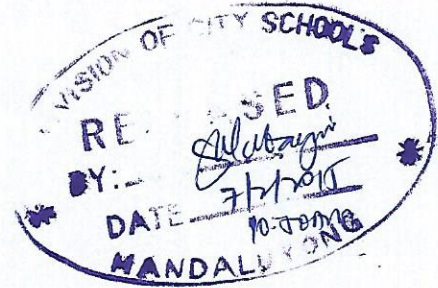




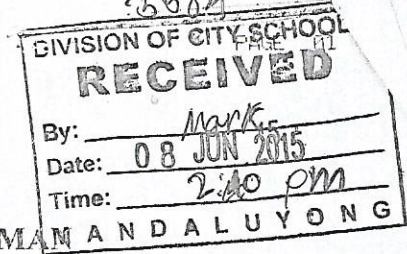

The Office of the Ombudsman acknowledges the support of the Division of Mandaluyong, Department of Education (DepEd) to the Campus Integrity Crusaders (CIC) program of the Office of the Ombudsman (Office) for the School Year (SY) 2014-2015. The CIC program, which accredits school-based student-organizations as Campus Integrity Crusaders, aims to empower the youth in their involvement in corruption prevention initiatives by developing their leadership skills and instilling the values of integrity and social responsibility.

For the Calendar Year 2014, a total of 381 organizations nationwide were accredited as CICs of the Office, 184 of which came from the school-based organizations (organizations) of secondary schools of DepEd National Capital Region (NCR), including the 11 organizations from DepEd-Division of Mandaluyong. These CICs nationwide implemented a total of 507 activities promoting integrity and social responsibility among their peers, 305 of which were implemented by the CICs from DepEd-NCR, including the 4 from the CICs of DepEd-Division of Mandaluyong.

For the School Year 2015-2016, the Office will start to engage again the student-organizations of secondary schools under your Division, for their accreditation as CICs and implementation of CIC-enrolled activities.

In this regard, may we request 3 officers of Campus Integrity Crusaders/Supreme Student Governments and 1 adviser from each of the 11 secondary schools under your Division to attend the CIC Orientation and Planning Workshop on 16 July 2015, 8:00 - 11:30 AM. The objective of the Orientation and Workshop is for the newly-elected officers of CICs/SSGs to appreciate the CIC Program and their role as integrity crusaders among their peers, in preparation for their accreditation as CICs and implementation of their CIC enrolled activities within the year. Attached is the Indicative Program of Activities.

To ensure the convenience of the participants, may we request that the activity be held at the DepEd Mandaluyong Conference Hall. Snacks will be provided by the Office for all the participants.
